Topics:

1. Approval of meeting minutes (Special Meeting 11/28/2023)

2. Discuss new employee application information to be required

Cunningham changed the new employee application. Bertolino looked at different applications from different towns from Auburn, Staunton, Rochester, and Chatham. 3. Social Media policy Required for employees

5. Discuss placing the Class F liquor license on the ballot

Craven was asked how can this get there. He said it can get there several different ways a referendum can end up on a ballot with or without council approval. 1. Non-binding advisory referendum majority vote from council to be put on the ballot. It should be done by ordinance so exact wording and time is specified. It must be a yes or no question. 2.

Citizens can put it on the ballot, but it would require about 95 citizen signatures. Discussed having the citizens being the one to put it to ballot instead of council.

- For special committee meeting agendas, where the policy come up to your house and you have to sign, Cunningham would like to be removed from that. She gets the emails and that is unnecessary.
