## 5. Speeding on Cemetery Road

People keep complaining about speeding. Mitch suggests putting a speed sign there. Steven brought up an electronic radar speed sign a few months ago. You can set the speed you want it set at and if they go above that speed it flashes red and blue and catches their information. It catches the time and date and you can pull up a log of data and determine when it occurs. Gary says it is in Steven's budget to get it out of purchase of equipment. How much are they? The last quote we got was just over \$3,500.
