## **Comments from the Audience:**

**Shannon Morenz** (co-owner of Jo's Place) voiced her displeasure with the doubling of the liquor license fees. Later stating that gaming would take money away from her restaurant and bar.

**Ken Williams** (owner of K&K) also voiced his displeasure with the new liquor license fee, stating that he hasn't raised his beer prices in 15 years.

**Miranda Jones** said she felt duped because she did not realize that Gaming licenses was going to be included in the discussion about raising Liquor Licenses. She stated that if beer and wine were sold for \$1 or \$2, everyone in the town would be going into gamble. She talked about the Girard business and her recent email. She then focused or her addiction to gambling and that putting machines in the bars (where she worked) caused her to relapse. She stated that Virden has a very good police force, however

she does not feel safe, and poverty/theft would increase. She said that with Virden not having a Newspaper the word is not getting out. She stated that if 3 gaming places were allowed then the other businesses would lose money.

Nathan Williams (Pastor at Grace Baptist Church and a five year resident of Virden) added his voice to Miranda Jones. He talked about his work with the Homeless Ministries in Fort Worth TX and said the vast majority of the homelessness was due to substance abuse, and how this is a reality. He said that bringing this into the town preys upon the weak and this is a poverty stricken area and bringing gaming is just taking advantage of the people. It is just not worth the little revenue that it would bring in. Gaming would further break the town and would only cause more problems and make the people feel unsafe and break their souls. He talked about the homeless children in Thailand and how they were left behind by addicted parents that loved them, and this is what we are bringing into the town.

**Mark Doane** (Pastor of the Virden Methodist Church) he echoed Natham Williams. He said there is an ample amount of establishments here that people go to and spend their money drinking liquor and gambling, the things that destroy families. He stated that with an issue this important, it should be on a ballot and let the people of the city decide, not be decided by the few people on the council.

**Patty McClain** talked about negative things she has seen in Alton and North St. Louis County. She has seen heroin addicts, and this could happen to Virden. She said there are ample gambling machines already because she has never had to stand in line to use one. She said that she did not want Virden to become like one of the other cities that she has lived in.

**Rick Maguire** inquired about reestablishing the Park Board or Committee.

## Police:

# 1. Sergeant Promotion

**Motion** made by Boster seconded by Donley to promote Officer Harold Gist to the rank of Sergeant effective immediately (10-6-25) which includes a \$1 an hour pay raise according to the union contract.

**Discussion:** Bertolino ask if the shift for the Sergeant (M-F 7:00 am to 3:00 pm will be the same as the Chief's shift.

The issue was discussed in committee about having 2 supervisors on the same shift. Boster answered Yes at this time. The officer's schedules are up to the Chief of Police and the Mayor.

  - **a. Update on Dean Street:** The project (to widen the streets and improve the sidewalks) will be starting on the 13th of October 2025 and is scheduled to be completed on the 14th of November 2025.
  - b. **Take action on Northwest Pipeline Construction:** bid issue tabled to Executive Session
- 2. Building and Grounds
  - a. Approve tree and stump bid

**Motion** made by Bertolino seconded by Karrick to approve the bid from Whalen and Sons LLC to remove 15 trees and 19 stumps at a sum not to exceed \$15,000. Work to be completed during city hours and trees are to be cut up to a length that will be easy for the city to haul away.

a. Approve change request #2, from MB Construction:

**Motion** made by Bertolino seconded by Boster to approve the contract change order #2 with MB construction for water meter replacement in the amount of \$4.651.

**Discussion**: This motion is not to pay them, only to approve the change order to the work that was done. The Director of Public Works has verified and approves the change order.

**Motion** passed with all in favor

**b. Consider pay application #3, MB Construction:** The Director of Public Works has verified that everything is working, in regard to the water meter replacement project.

**Motion** made by Boster seconded by Matrisch to approve pay application #3 to MB Construction for \$26,848.05.

**Discussion:** This is their final payment.

**a. Approve line item transfer in Public Works** This is to help pay for the stump and tree removal.

**Motion** made by Boster seconded by Karrick to approve line item transfer requests from line item 01-02-4002S for \$4000 and from 01-02-4007 for \$3000 to 01-02-4004 for the total amount of \$7000.

**NOTE** Mayor Murphy said that he will be vetoing the vote in writing within the next 5 days and it cannot be voted on until the next regular scheduled City Council meeting. It will take 2/3 (6 Alderpersons) to override the Mayor's veto.

- **7. Policy changes** Bertolino asked if anything special needs to be done if the city adds Training Requirements in the manuals for its employees. The attorneys responded, "just let the unions know in writing". An email should be ok.
- **8. Utility Easements (sinkhole ordinance)** The city has developed an hourly rate for the use of city equipment and will submit it to the Attorneys who will write up an ordinance.
