

**AN ORDINANCE AMENDING TITLE 3 OF THE CITY CODE OF ORDINANCES**

*BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VIRDEN, ILLINOIS, AS FOLLOWS:*

**SECTION 1: AMENDMENT OF SECTION 3-1B-6**

Section 3-1B-6 of the City Code of Ordinances is hereby amended to include subsection (G), which shall read as follows:

- G. Class G, Video Gaming Parlor (Beer & Wine Only) License: There is hereby created a Class G liquor license which shall permit the retail sale of beer and wine for consumption only on the premises where sold and not for resale in any form. The annual fee shall be one thousand two hundred dollars (\$1,200.00). There shall be a limit of three (3) licenses.

**SECTION 2: AMENDMENT OF SECTION 3-1C-3**

Section 3-1C-3 of the City Code of Ordinances is hereby amended to include subsection 1(f), which shall read as follows:

- f. Class G license: Same as Class A.

**SECTION 3: Effective Date; Publication**

This Ordinance shall be effective upon its passage, approval and publication as provided by law. The Clerk shall forthwith publish this Ordinance in pamphlet form.


