

Ordinance No. 2026- 01

**AN ORDINANCE AMENDING THE CITY CODE OF ORDINANCES  
(Water Department income)**

*BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VIRDEN, ILLINOIS, AS  
FOLLOWS:*

**SECTION 1: AMENDMENT OF SECTION 7-1-10**

Section 7-1-10 of the City Code of Ordinances is hereby amended to read as follows:

**DISPOSITION OF REVENUES:** All revenues and monies derived from the operation of the Water System shall be deposited in the water account of the Water Fund. All such revenues and monies shall be held by the City Treasurer separate and apart from his private funds and separate and apart from all other funds of the City Treasurer not more than 10 days after receipt of same, or at such more frequent intervals as may from time to time directed by the City Council. The City Treasurer shall receive all such revenues from the water system and all other funds and monies incident to the operation of such system as the same may be delivered to him and deposit same in the account of the fund designated as the "Water fund of the City". The Treasurer shall administer such fund in every respect in the manner provided by 65 ILCS 5/3.1-34-40 et.seq.


All revenues and monies derived from the operation of the Water System shall be deposited in the water account of the Water Fund and shall be expended entirely within the Water Fund and shall not be transferred to any other fund for purposes unrelated to Water Department operations, except by ordinance adopted by the affirmative vote or 75% of all aldermen then in office.

**SECTION 2: Effective Date; Publication**

This Ordinance shall be effective upon its passage, approval and publication as provided by law. The Clerk shall forthwith publish this Ordinance in pamphlet form.
